Trojan Ethical Fund

The investment objective of the Trojan Ethical Fund is to provide capital growth (net of fees), ahead of inflation (UK Retail Price Index), over the longer term (5 to 7 years). Its investment policy is to invest across a broad range of asset classes. Whilst asset allocation will vary, in general, the investment universe will comprise high-quality, developed market equities, developed market government bonds, gold related investments, cash and money market instruments (such as treasury bills). The portfolio will be constructed with input from both top-down analysis (looking at an economy as a whole) and bottom-up analysis (study of individual securities). The Fund will invest in accordance with the parameters of its Ethical Exclusion Criteria.





November Commentary

Your Fund returned $\pm 0.2\%$ during the month compared to $\pm 7.1\%$ for the FTSE All-Share Index (TR).

Nestlé has been held in Trojan Ethical Fund since inception, originally purchased at around CHF 93.86 or £71.50. Its brands span coffee, pet food, confectionary and specialty nutrition. Over 30 of these brands have sales exceeding CHF 1bn per year. Nestlé's strength comes from its breadth of operations spanning 187 countries, as well as the impressive execution under CEO, Dr Mark Schneider. The company also owns a 20% stake in L'Oréal, providing additional exposure to another high-quality business. The shares (in sterling) ended November 2022 at around £99, giving a return of +53% from our initial purchase when dividends are included.

Nestlé recently held a capital markets day, which was attended by a member of our team, our take away was that the company is in rude health. Nestlé expects to deliver mid-single digit sales growth with gently expanding


operating margins leading to forecast annual earnings per share growth of 6-10% to 2025. Tight cost control and healthy free cash flow generation allow the company to invest for the long-term in favoured areas such as its Health Science division while cutting underperforming investments. This drives an attractive forecast return on invested capital of 15%.

Nestlé remains an unassuming but powerful long-term investment for the fund
