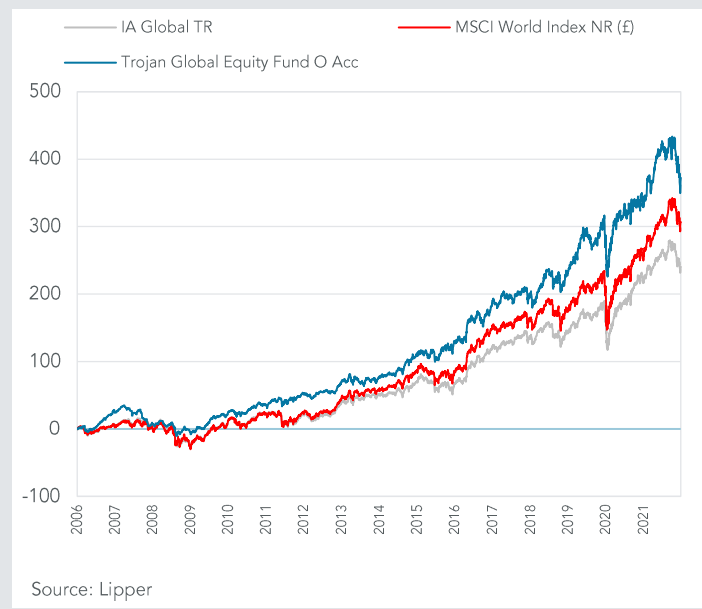

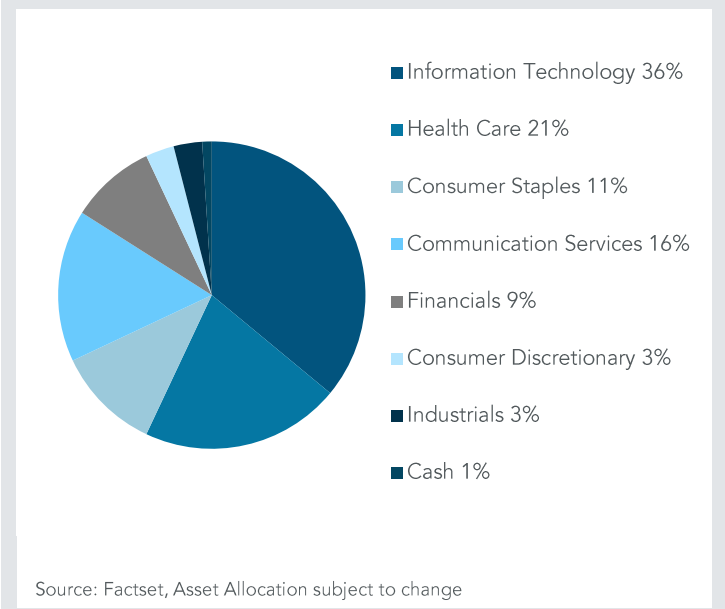

February Commentary

Your Fund returned -4.8% during the month compared to -2.5% for the MSCI World Index NR (£).

PayPal fell -25% on 2 February after publishing quarterly results. Meta Platforms (formerly Facebook) sunk by a similar amount the next day. These two shocks account for roughly half the Fund's decline in the month.

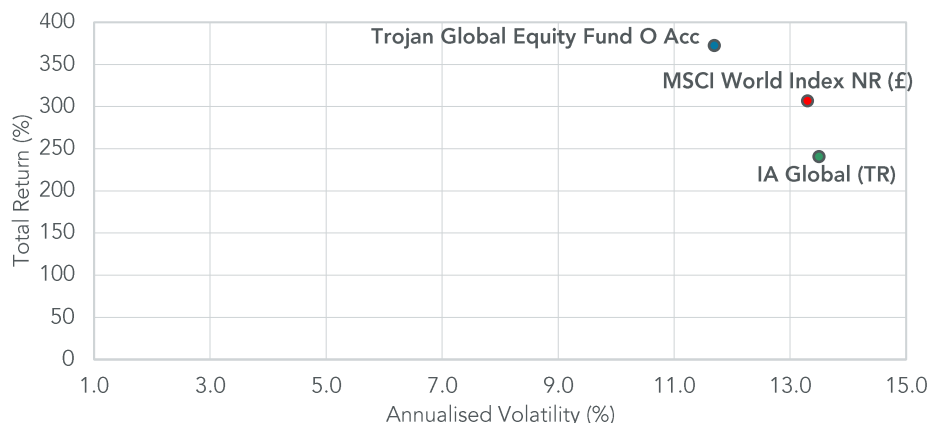
In such 'Man Overboard' moments, it is unwise to leap to conclusions. We carefully analyse the news and formally review our investment. PayPal is the most disappointing. Already a poor performer for reasons

previously explored (see [here](#)), a softer outlook for earnings combine with an abrupt shift away from a user-led model for revenue growth. PayPal's ability to attract and retain users is not as strong as management (and we) had thought, denting our confidence in the franchise and its leadership. That notwithstanding, it is important to keep an eye on PayPal's enduring strengths. The unusual scale and efficacy of its branded network ensures it will likely remain a winner in e-commerce payments for many years to come. The shares now offer substantial value for a business still capable of outstanding growth in revenues, profits and cashflows.

The issues at Meta are more complicated, involving multiple external pressures and self-imposed constraints. It is easy to miss the wood from the trees. In general, we suspect investors underestimate the company's vast resources to compete and adapt, together with management's track record to flexibly make the right long-term choices. Meta is one of the most undervalued companies in the portfolio, in our view.

We added to investments in Adobe, Meta, Moody's and PayPal during the month, funded by reductions to Booking Holdings and American Express, among others.
