

We started a new investment in June in ADP. ADP is the leading provider of payroll software in the US - 1 in 6 employees in the US are paid using software provided by ADP. We know the sector well given our existing investment in Paychex, a peer to ADP. While Paychex focusses on small businesses in the US, ADP serves a wider set of customers, both in the US growth. and abroad.

The company has little debt on its balance sheet and has significantly upgraded its product suite in the last few years.

> Despite the rise in unemployment in the US and globally, we believe ADP is more resilient than investors realise, as evidenced by the 46 years of uninterrupted dividend growth. The current dividend yield of 2.4% represents an attractive valuation even in the context of weaker short-term
